## HILLSBOROUGH COUNTY REPUBLICAN COMMITTEE 2017 GUN RAFFLE RULES

- 1 A maximum of 1,000 tickets will be sold. Sales end September 16<sup>th</sup>, 2017. Prizes will include guns and other gun-related prizes (e.g.: training).
- 2 Ticket price is \$20.00. Each ticket will be valid in ALL raffle drawings. Total number of guns to be offered will be at least 6 and the maximum depends upon donations received. A complete list of the guns and other prizes to be raffled will be available at [www.Hillsborough GOP.org](http://www.HillsboroughGOP.org).
- 3 Apply for tickets online at [www.Hillsborough GOP.org](http://www.HillsboroughGOP.org) through Eventbrite, or by mail using the form below (also available for download at [www.HillsboroughGOP.org](http://www.HillsboroughGOP.org)), or by buying a printed ticket from HCRC members or others.
- 4 By applying for a raffle ticket, you attest that you: are 21 years of age or older, are a legal resident in the United States, are a law abiding citizen of good moral character, may legally possess any gun won, have intention of using any gun won only in a legal and safe manner, and will obtain or have already obtained instruction on the safe use and operation of any gun won.
- 5 Purchasers will receive a confirmation of their purchase and a numbered receipt at the email address entered online or on the application form. If the email address is invalid, a confirmation letter will be sent by mail to the purchaser at the physical address provided. Purchasers of printed tickets will receive a numbered receipt.
- 6 Applications will be returned if they are received after 1,000 tickets have been sold.
- 7 Tickets are sold by, and proceeds will benefit, Hillsborough County Republican Committee (HCRC). Tickets are NOT tax-deductible. Tickets are non-refundable.
- 8 Every ticket purchased will be issued a numbered raffle ticket that will be used in the drawings. HCRC will conduct separate drawings for each of the guns and then for any other prizes to select a winning ticket for each specific prize. Each drawing will be made from all of the tickets purchased up to the date of the drawing. Winning tickets drawn are included in the remaining drawings. The drawings will be on Saturday September 16, 2017 at the HCRC Constitution Day Picnic, and all drawings will be completed on that date. HCRC reserves the right to change the specific date of the drawings.
- 9 Raffle is conducted with the approval of the Town of Bedford, NH. Drawings will be held at Murphy's Carriage House, 393 Rte. 101, Bedford, NH.
- 10 HCRC will announce the winners at the Constitution Day Picnic on September 16, 2017 and the winners will be posted on the HCRC web site. To preserve their privacy, only the winners' first name and the first letter of their last name will be posted at [www.Hillsborough GOP.org](http://www.HillsboroughGOP.org).
- 11 The donor of each specific gun or other prize will be notified of the name of the winning ticket holder in the raffle of that prize. Winning ticket holders will be notified by mail at the address they provided. HCRC will not be responsible if mail delivery cannot be made to the address provided.
- 12 Guns and other prizes are not transferrable. The winner of each raffle can claim only the gun or prize in that specific raffle, and only the winning ticket holder may claim the gun or prize. All guns and other prizes won are subject to availability. HCRC and donors of gun or other prizes reserve the right to make a substitution of equal or greater value if the gun or other prize won is not available.
- 13 The winning ticket holder is responsible to claim the gun or prize they have won, and to provide any information required, and pass any criminal or other background checks required, to legally take possession of the gun or prize. Inability to do so, for any reason, will result of forfeiture of the ticket and winnings.
- 14 Winning ticket holders must make gun transfers through the donor of the gun, if they are a Federal Firearms Licensed (FFL) dealer, or through the FFL chosen by the donor. All applicable Federal and State laws and all Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF) regulations will apply, including, with respect to each winning ticket holder, the laws of the State of his or her legal residence. The winner is responsible for any transfer fees.
- 15 In the event a winning ticket holder needs or wishes to have the gun won transferred to a local FFL dealer closer to his or her residence, shipping and any other additional costs involved with the transfer will be the responsibility of the winning ticket holder, and arrangements must be made directly between the winning ticket holder and the FFL selected by the gun donor.
- 16 EACH GUN WON MUST BE CLAIMED AND ITS TRANSFER MUST BE COMPLETED WITHIN 30 DAYS OF ITS RAFFLE DATE. Unclaimed winnings and ticket will be forfeited.
- 17 This raffle is void where prohibited.
- 18 HCRC makes no, and is not liable or responsible for any, warranty, representation, or guarantee relative to any gun or other prize won, including its quality, condition or suitability or fitness for a particular purpose. Any and all warranties, representations, and guarantees are subject to the gun or prize manufacturer's terms, if applicable.
- 19 HCRC and all Donors and any FFL associated with this raffle limit any and all liability to the purchase price (\$20.00) of the raffle ticket.
- 20 Eventbrite is not a sponsor or administrator of, and is not in any way affiliated with, this raffle. HCRC provides a complete release from participants of Eventbrite from any and all liability related in any way to this event.
